KaPre FulvaGrow Concentrate can be applied to all crops including vegetables, row and field crops, feed crops, trees, nut trees and vines as well as to ornamentals, garden landscaping, lawns and golf course greens, tees and fairways.

KaPre FulvaGrow Concentrate can be applied with all transplant solutions, dips and all watering solutions. It can be applied to all soil types and pH ranges at a rate up to 2.5 gallons per acre.

KaPre FulvaGrow Concentrate can be mixed with most liquid fertilizers. **KaPre FulvaGrow Concentrate** can also be mixed with most pesticides including non-selective contact herbicides, systemic insecticides, fungicides and defoliant.

Compatibility

KaPre FulvaGrow Concentrate is compatible with most common foliar pesticides, liquid nutrients and micronutrients; however, USER ASSUMES FULL RESPONSIBILITY to ensure compatibility when tank mixing with other products.

Do not mix with pesticides or other chemicals without a compatibility test. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients. If unfamiliar with FulvaGrow's use, check with a LidoChem, Inc. representative.

General Recommendations

SHAKE WELL BEFORE USE

Foliar Applications to vegetables, row and field crops, feed crops, trees, nut tree, vines, ornamentals, garden landscaping, lawns and golf course greens, tees and fairways:

KaPre FulvaGrow may be applied at up to 12.8 ounces per acre per application. Apply at least 1.6 ounces per acre in all foliar applications. Use higher rates as the spray volume increases. **KaPre FulvaGrow** is recommended for application with all nutrient and pesticide sprays.

Application with other nutrients: Apply at a rate of 1.6 to 12.8 ounces per are in liquid starter or pop up fertilizers.

Application alone (without other nutrients): Dilute in at least 10 gallons of water.

Greens, Tees and Other Turf Applications: Apply with all foliar nutrient applications at a rate of 1.6 ounces per 25 gallons of spray volume. Apply before, during or after stress periods at 3.2 to 6.4 ounces per acre.

Ornamental Applications: Apply with all foliar nutrient applications at a rate of 1.6 ounces per 25 gallons of spray volume. Apply before, during or after stress periods at 3.2 ounces per per 25 gallons of spray volume.

Transplanting or Cutting Applications: Mix 3.2 ounces per 20 gallons of solution.

Foliar Applications Turf and Ornamental: Broadcast spray or inject into irrigation at 12.8 ounces per acre, 1 to 3 times during the season. Application is targeted at the soil; however, foliar contact is not detrimental.

Mix with deep root injections at 6.4 ounces per 10 gallons of injection solution.
