Application Instructions

Application Rate:

Apply 1.35 to 11.0 pounds of KaPre PRO 11-2-3 per 1,000 ft² or 60 to 480 pounds per acre (0.125 to 1.0 pounds of N per 1,000 ft² and 6 to 50 pounds of N per acre, respectively).

Application Timing:

Begin applications in the spring and apply every 2 to 4 weeks for sand-based greens and 2 to 6 weeks for native “push-up” profiles (higher application rates require less frequent applications).
