FIRST AID

INGESTION:

Hold eyelids apart during the flushing to ensure rinsing of entire surface of the eye and lids with water. DO NOT let victim rub eye(s). Do not attempt to neutralize with chemical agents. Oils/ointments should not used at this time. Get medical attention if eye irritation occurs.

SKIN IRRITATION:

In case of contact, immediately wash with plenty of soap and water for at least 15 minutes. Seek medical attention. Remove contaminated clothing and shoes before reuse or discard if they cannot be thoroughly cleaned.

INHALATION:
