SIGNS & SYMPTOMS OF EXPOSURE

ACUTE: At high dust concentrations, irritation of eyes, skin, nose and upper respiratory tract by chemical or mechanical action may occur.

FIRST AID

INGESTION:

EYE IRRITATION:

Flush eyes with large quantities of running water for a minimum of 15 minutes. If present and easy to do, remove contact lenses. Hold eyelids apart during the flushing to ensure rinsing of entire surface of the eye and lids with water. **DO NOT** let victim rub eye(s). Do not attempt to neutralize with chemical agents. Oils/ointments should not be used at this time. If eye irritation persisted, get medical attention.

SKIN IRRITATION:

Remove contaminated clothing and equipment. Wash all affected areas with plenty of soap and water for at least 15 minutes. Do not attempt to neutralize with chemical agents. Wash contaminated clothing and shoes before reuse. Get medical advice if irritation occurs.

INHALATION:

Remove victim from immediate source of exposure and assure that the victim is breathing. If breathing is difficult, administer oxygen, if available. If victim is not breathing, administer CPR (cardiopulmonary resuscitation). Seek medical attention.
