FIRST AID

INGESTION:

If victim is conscious and alert, give 2-3 glasses of water to drink and do not induce vomiting. **Never give anything to eat or drink to someone who is unconscious, having convulsions, or unable to swallow.** Seek immediate medical attention. Do not leave victim unattended. To prevent aspiration of swallowed product, lay victim on side with head lower than waist. Vomiting may occur spontaneously. If vomiting occurs and the victim is conscious, give water to further dilute the chemical.

EYE IRRITATION:

Hold eyelids open and flush with a steady, gentle stream of water for at least 15 minutes. If present and easy to do, remove contact lenses. Seek immediate medical attention, preferably with an ophthalmologist. If the physician is not immediately available, eye irrigation should be continued for an additional 15 minutes. If it is necessary to transport the patient to a physician and the eye needs to be bandaged, use a dry sterile cloth pad and cover both eyes. DO NOT let victim rub eye(s). Do not attempt to neutralize with chemical agents.

SKIN IRRITATION:

In case of contact, immediately wash with plenty of soap and water for at least 15 minutes. Seek medical attention. Remove contaminated clothing and shoes before reuse or discard if they cannot be thoroughly cleaned.

INHALATION:

Remove victim from immediate source of exposure and assure that the victim is breathing. If breathing is difficult, administer oxygen, if available. If victim is not breathing, administer CPR (cardiopulmonary resuscitation). Seek medical attention.
