#### **SIGNS & SYMPTOMS OF EXPOSURE**

Possible irritation to eyes, nose and throat. Large doses may cause nausea, vomiting and diarrhea. Systemic oral toxicity is extremely rare and has consisted of acidosis and hypocalcemia tetany.

# **FIRST AID**

#### **INGESTION:**

If victim is conscious and alert, give 2-3 glasses of water to drink and DO NOT INDUCE VOMITING. If vomiting occurs and the victim is conscious, give water to further dilute the chemical.

#### **EYE IRRITATION:**

Hold eyelids apart during the flushing to ensure rinsing of entire surface of the eye and lids with water. DO NOT let victim rub eye(s). Do not attempt to neutralize with chemical agents.
