## HANDLING AND STORAGE

Avoid direct or prolonged contact with skin and eyes. Store in tightly closed containers in a cool, dry place when not being used. Product is hygroscopic. Ambient temperature (below 25°C / 77°F) Avoid raising dust.

## STEPS TO TAKE IN CASE MATERIAL IS SPILLED

Do not touch or walk through spilled material. Keep Unauthorized personnel away. After wearing and using recommended protective equipment, stop source of spill if safe to do so and dike area to contain spill. See Section 8 for personal protective equipment.

Stop source of spill if safe to do so. Sweep up spilled solid material, being careful not to create dust. Use clean non-sparking tools and equipment. Return sweeping to stock or, if contaminated, place into a chemical waste container for disposal. Wash away residue with water, without contaminating drains. Soak up wash water with suitable absorbent or sand, sweep up and dispose of in accordance with local regulations.

## FIRST AID

### INGESTION:

If victim is conscious and alert, give 2-3 glasses of water to drink and do not induce vomiting. **Never give anything to eat or drink to someone who is unconscious, having convulsions, or unable to swallow.** Seek medical attention if health effects occur. Do not leave victim unattended. To prevent aspiration of swallowed product, lay victim on side with head lower than waist. Vomiting may occur spontaneously. If vomiting occurs and the victim is conscious, give water to further dilute the chemical.

### EYE IRRITATION:

Flush eyes with large quantities of running water for a minimum of 15 minutes. If present and easy to do, remove contact lenses. Hold eyelids apart during the flushing to ensure rinsing of entire surface of the eye and lids with water. DO NOT let victim rub eye(s). Do not attempt to neutralize with chemical agents. Oils/ointments should not be used at this time. Get medical attention if eye irritation occurs.

### SKIN IRRITATION:

Remove contaminated clothing and equipment. Wash all affected areas with soap and water for at least 15 minutes. Do not attempt to neutralize with chemical agents. Wash any contaminated clothing and shoes before reuse. Obtain medical advice if irritation occurs.

### INHALATION:

Remove to fresh air. Rinse nose and mouth with water. Get medical attention. If breathing becomes difficult, oxygen may be given, preferably with a physician's advice. If not breathing, give artificial respiration. Get medical attention if irritation occurs.
